**PROMOTION DESCRIPTION:** The Darvin Furniture & Mattress "Chicago Wins You Win" Promotion (the "Promotion") takes place from September 8, 2026 to September 21, 2026 during regular business hours (the "Qualifying Period"). Participation in the Promotion does not constitute participation in any other promotion, contest, or sweepstakes. By participating in the Promotion, each participant unconditionally accepts and agrees to comply with and abide by these Terms and Conditions and the decisions of Darvin Furniture & Mattress, 15400 LaGrange Road, Orland Park, IL 60462, which shall be final and binding in all respects.

**ELIGIBILITY:** Only residents of Illinois, Indiana, Michigan, and Wisconsin who are (18) years of age or older with a valid format of identification are eligible to participate. Employees, officers and directors of Sponsor, its parent, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the "Promotion Entities") and the immediate family members, and/or those living in the same household of each are not eligible to participate in the Promotion.
