

## **WEIR'S \$1,000 SHOPPING SPREE SWEEPSTAKES – 1<sup>st</sup> QUARTER 2026 – OFFICIAL RULES**

No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Winner will be awarded a \$1,000 Weir's Furniture Gift Card.

The Weir's \$1,000 Sweepstakes 1<sup>st</sup> Quarter 2026 will be referred to as the "Sweepstakes".

### **ELIGIBILITY**

To enter the Sweepstakes, you must be a legal residents of the United States living within a 250 mile radius of any of our 4 store locations in Dallas, TX; Plano, TX; Farmers Branch, TX; or Southlake, TX, and you must be at least 18 years of age at the time of entry. Employees of Weir's Furniture Village, Inc., its Board of Directors, Shareholders, Family members and immediate family of such persons (spouse, parent, child, sibling, grandparent or "step" of each), and persons living in the same household of each, whether related or not, are prohibited from entering the Sweepstakes.

### **AGREEMENT TO THE OFFICIAL RULES**

There are 2 ways to enter during the entry period:

#### **ONLINE**

The online Sweepstakes entry form may be found on the Weir's website at [www.weirsfurniture.com](http://www.weirsfurniture.com) where a participant may complete the online form and submit their entry. Participants must provide their full name, zip code, phone number and valid email address to enter the promotion. Each participant will receive one (1) entry into the Sweepstakes for a completed and correctly submitted online entry.

#### **MAIL-IN**

**LIMIT**

One (1) entry per person, per entry period, regardless of the method of entry, and regardless of the number of email addresses.

**WINNER SELECTION AND NOTIFICATION**

Sponsor will randomly select the potential winner from all eligible entries received during the entry period during the first week of April, 2026. Each Potential Winner will be notified by email and/or telephone, as determined by Sponsor. Messages may not be left. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a Potential Winner for any reason.

If, despite reasonable efforts, a Potential Winner does not respond within seventy-two (72) hours of the first notification attempt, such Potential Winner may, in Sponsor's sole discretion, forfeit his or her prize and an alternate Potential Winner may be selected.
