

# Karvonen's 100 Year Sweepstakes

## Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

### Dates of Sweepstakes

Sweepstakes begins at 12:00:01am Central Time ("CT") on January 19, 2026 and ends at 11:59:59pm CT on December 15, 2026 (the "Sweepstakes Period").

### Eligibility

Karvonen's 100 Year Sweepstakes ("Sweepstakes") is open only to legal residents of, and physically located within, Minnesota and North Dakota, age eighteen (18) years or older at time of entry. Void where prohibited. All federal, state, and local laws and regulations apply. Employees and representatives of Karvonen & Son, Inc ("Sponsor") and of any Administrators identified at the end of these Official Rules, and any of their respective parents, affiliates, subsidiaries, licensees or designees, as well as their immediate family members (herein, defined as spouses, parents/stepparents, siblings, children/stepchildren and each of their respective spouses, regardless of where they reside) and members of their household (whether related or not) are not eligible to participate. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes and shall not be subject to appeal.

**How to Enter.** There are three (3) ways to enter:

**Online Entry Form:** Entrants who visit our physical location and scan the QR code may complete a "Free Entry" entry form. Entrants who visit [karvonens.com](https://karvonens.com) may complete the "Free Entry" entry form on the Sweepstakes page. In either case, the entry form must be completed in its entirety to include first and last name, phone number, mailing address, and email address.

**Purchase:** Entrants making a purchase at [karvonens.com](https://karvonens.com) or Karvonen's (Sponsor) physical location during the Sweepstakes Period may complete a "Bonus Entry" entry card at the time of purchase. Participants will receive one (1) entry per \$500 in furniture or mattress purchases and one (1) entry per \$1000 in appliances. Entry multipliers may be added to specific products or entire orders at the Sponsor's discretion. Only the subtotal (excludes tax, delivery, discounts, credits, etc) will be used to calculate the number of entries awarded. Entry multipliers are subject to change and will vary by product and day.

The entry form must be completed in its entirety to include first and last name, phone number, mailing address, and email address. For online purchases, customers must either request an entry be mailed or visit Karvonen's physical location within one month of purchase to complete the entry card.

**Write-In:** To enter by mail without visiting our physical location, website, or by making a purchase, legibly handwrite your complete name, mailing address, phone number, email address, & date of birth and mail a postcard or letter with proper postage to: Karvonen's 100 Year Sweepstakes, 151 W Main Street, Perham MN 56573. All write-in entries must be postmarked by December 10, 2026 and received by December 15, 2026. There is a limit of one (1) write-in entry per envelope/postcard. Each envelope/postcard is considered one(1) entry into the Sweepstakes. Multiple entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Write-in entries must contain all entry fields outlined above; otherwise, they are void and will not be eligible to win. There is a limit of one (1) write-in entry per day.

The Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

**Entry Limit:** the maximum number of entries allowed per person, regardless of method of entry, is five hundred (500). Entries submitted in excess of this limit will be void.

### Drawing/Odds

On or about December 16, 2026, potential prize winners will be selected in a random drawing from all eligible entries. Odds of winning depend on the number of eligible entries received for the Sweepstakes. Each individual entry has an equal chance of winning.
